

Only one change of the form of government is needed to dissolve it, but...
below are eight that are in common knowledge rendering full undeniable dissolution.

DISSOLUTION #1:

The President of the united States of America cannot send troops across the street much less to foreign nations without a declaration of war by Congress. Many "Presidents" have sent troops to fight and die without a declaration of war which is clearly usurpation and a change in the form of government without the consent of the people in the form of the required amendment to the constitution.
